Introduction

This Annual Investment Plan was prepared in a consultative manner spearheaded the County Program Committee Members and other technical officers from the County Government. Members of the public further gave their contributions in terms of priority projects during community sensitization workshops and citizen fora.

Investment prioritization

Priorities as identified by the Technical Team beautification of Kilgoris Town i.e. Improvement of drainage system, paving of walk ways and cycle lanes, Erection of street Signage and furniture, planting of trees, installation of waste collection bins and solar powered street lights, beautification of major streets, construction of Modern Bus terminus at Kilgoris, storm water projects, construction and upgrading of major urban roads and purchase of land for cemetery and waste disposal. The County Executive, in consultation with the County Assembly, proposed to the municipality to undertake projects in improving Urban Economic Infrastructure, markets (lighting and securing, access, market drainages, parking, safety and waste management), Road networks, Sewer systems, Bus parks and Non-Motorized Transport facilities, greening of public places, Fire and disaster management. The citizens proposed projects as captured in the attached Annex (As extracted from the CIDP).

Through exhaustive public participation majority agrees is to undertake the Improvement of Major roads to Bitumen standards including construction of Non Motorized transport facilities, storm water drainage facilities and waste collection bins at an approximate cost of Kshs, 50,000,000.

Project 1: Improvement of selected urban road to bitumen standards including NMT & Storm Water drainage improvement

The project entails giving a facelift to one major urban road in Kilgoris to bitumen standards. The components in the project include; improvement of storm water drains, paving of pedestrian and cycle lanes, erection of Signage and street furniture, planting of trees, installation of waste collection bins and solar powered street lights. The infrastructure improvement in Kilgoris CBD will further enhance its functionality, attractiveness and development of the local economy. This will further translate into improved and alternative livelihoods for the residents and increased revenue generation by the Municipality.
